

# Yale University

## Student Bond

Yale requires that each student's parent, legal guardian, or sponsor sign this student bond form. No student is fully enrolled at Yale until the form has been properly completed and returned to Yale University; students will be unable to obtain official documents such as transcripts or diplomas without a fully executed student bond on file. Every student must have an adult sponsor, even those students expecting to pay their expenses themselves or those receiving financial aid for a large portion of their expenses.

By signing, you agree to guarantee payment of all amounts of money that your child or ward or student you have agreed to sponsor (the "student") owes Yale. You promise to pay the University in full with interest (if any is due). This guarantee includes tuition, room and board, and other items which the University allows the student to charge to his or her university accounts. It also includes all payments of principal and interest, whether accruing before or after the student's graduation, on all Yale loans other than those made under a federal program the laws and regulations of which do not allow a guarantee like this one. This guarantee is separate from any other financial agreement you or the student may have with Yale. This guarantee remains valid whether or not Yale makes an arrangement with the student, such as allowing a time extension on paying his or her account. Also, you agree that this guarantee will bind your executors or administrators. Finally, this agreement survives the graduation or other separation from the University of the student. It remains in effect until the time that the student both is no longer enrolled in any school or department of Yale and also no longer owes Yale any money. You promise to pay all collection costs, including, but not limited to, attorney fees, court costs, and collection agency fees, which may be based on a percentage of the outstanding balance. You authorize Yale and its agents and contractors to contact you regarding your student account balance, including repayment of your balance, at the current or any future number that you provide for your cellular phone or other wireless device using automated telephone dialing equipment or artificial or pre-recorded voice or text messages. The bond requires three signatures: those of the sponsor, the student, and a witness. The witness, who may be a member of the student's family, must be present to observe the signature of the sponsor, but need not witness the student's signature. The bond must be dated and must include the address of each of the three signatories.
